Liquor Control Commission June Underage Compliance Report

SPRINGFIELD – In **June** the Illinois Liquor Control Commission (ILCC) conducted compliance checks around the state and visited 364 businesses licensed to sell liquor. They cited 64 for violations of liquor control laws. Eighty-two percent of the licensees visited complied with Illinois liquor laws and refused to serve underage customers.

This report is a result of ongoing undercover and cooperative law enforcement operations conducted by Illinois Liquor Control Commission (ILCC) agents and local law enforcement officials and volunteers from high schools and colleges. The teams randomly visit liquor stores, restaurants and bars in communities around the state to check for ongoing compliance with state laws mandating that no liquor is sold to minors under the age of 21. ILCC agents also work with local and state law enforcement agents to focus on communities with a high incidence of underage liquor sales.

Algonquin – June 27, the ILCC and the Secretary of State Police conducted underage alcohol checks in Algonquin in McHenry County. Of the 15 licensee's checked, none sold alcohol to ILCC underage participants.

Alsip – June 19, the ILCC and Secretary of State Police Department conducted underage alcohol checks in Alsip. Of the 15 licensees checked, two sold alcohol to LCC underage participants. Those licensees were:
