RE: Unified Economic Development Budget

Pursuant to the Corporate Accountability for Tax Expenditures Act, the Department of Revenue is submitting the annual Unified Economic Development Budget, as found in 20 ILCS 715/10 for Fiscal Year 2011.

Tax incentive amounts reported in the Unified Economic Development Budget are totals from tax returns for tax years ending during Fiscal Year 2011. Prior reports were reported on a tax year basis and are not strictly comparable to this year's report. For the following reasons, the tax incentive amounts reported do not represent the cost of these incentives to the state during Fiscal Year 2011: tax credits (lines 1-36 of the attached report) may be earned during the year but used in a subsequent year because the taxpayer did not have sufficient current year tax liability to deduct the credit, while subtractions (lines 37-52) reduce income subject to tax rather than tax liability. Additionally, in certain cases, tax benefits may flow from one entity to another entity and thus may be counted on multiple occasions in this report. The cost of the three Department of Commerce and Economic Opportunity (DCEO) incentives, shown at the bottom of the report, were provided by DCEO and represent actual amounts obligated during Fiscal Year 2013.
