
Federal Changes (including net operating loss (NOL) deductions)

- ◆ If you file Form IL-1040-X because you filed a U.S. Form 1040X that resulted in
 - an overpayment or because you are claiming an NOL carryback deduction, you must wait to file this form until you receive a federal finalization notice from the IRS stating that they have accepted your change either by paying a refund or by final assessment, agreement, or judgment. Write the date the IRS notified you (not the date you filed your U.S. Form 1040X) in the appropriate space in Step 1, Line E, and attach proof of federal finalization as listed below.
 - a balance due, you must attach a copy of your U.S. Form 1040X as proof of federal finalization. Write the date you filed

 result in an assessment of a late-payment penalty.


