The Recorder must contact the preparer to notify them that a new MyDec declaration is required due to the incorrect PIN. The preparer will submit, accept, and complete the closing for the new correct declaration. Once this is all complete, the Recorder will be able to re-record through their software. This will authorize new stamps, but the Recorder will not have to collect additional revenue since the user has already paid them and the previous stamps were voided.
