## Non-MyDec County Only - Correct Invalid Document Number

If, after data entry of a paper declaration in a Non-MyDec County (a county whose Clerk/Recorder does not use MyDec), the document number needs to be updated, the Assessor will complete the steps below.

## Assessor Action:

1. The Assessor must unfinalize the assessment if it has been finalized. Select "Unfinalize Assessment". If the assessment has not been finalized, proceed to Step 3.
