 - A. <u>Impact on the public</u>: This rulemaking amends Part 140, Service Occupation Tax, to reflect new statutory developments.

Section 140.101 is amended to incorporate changes made by P.A. 103-0009 to dates as well as the percentages of proceeds subject to tax from sales of gasohol, majority blended ethanol fuel, and mid-range ethanol blends.

Section 140.125 is amended to incorporate changes made by P.A. 103-0009 to expand the exemption for materials, parts, equipment, components, and furnishings incorporated into or upon an aircraft to include aircraft engines or power plants and extends the exemption to December 31, 2029.

- B. <u>Changes in the agency's programs or structure resulting from</u> <u>implementation of the rulemaking</u>: None.
- C. Impact of proposed rule on small businesses. Methods used by Agency to comply with 5 ILCS 100/5-30, including reasons for rejecting any methods not utilized: This rulemaking simply implements new statutory developments. No additional skills are required to comply. The Department is currently implementing the Service Occupation Tax Act as required by P.A. 103-0009, and therefore, the methods described in 5 ILCS 100/30 are not legal or feasible in meeting the requirements of the Service Occupation Tax Act. The Department published the proposed rulemaking in the Illinois Register and on the Department's website.

 - A. <u>Any changes in statutory language requiring the proposed rulemaking:</u> Implements changes made by Public Act 103-0009 to the Service Occupation Tax Act codified at 35 ILCS 115/3-5(29) and 115/3-10.
