## ST-58, Reciprocal - Non-Reciprocal Vehicle Tax Rate Chart January 2023

Residents of states other than Illinois may not claim the nonresident purchaser exemption (Section 5, Box A of Form ST-556, Sales Tax Transaction Return) on purchases of motor vehicles or trailers that will be titled in a state that does not give Illinois residents a nonresident purchaser exemption on their purchases in that state of motor vehicles or trailers that will be titled in Illinois (*i.e.*, the other state offers no reciprocal exemption to Illinois residents). Motor vehicles leased to nonresidents using drive-away permits or transferring out-of-state vehicle registration plates will be exempt, regardless of the purchaser's state of residence. See instructions for Form ST-556-LSE, Transaction Return for Leases, for more information about this exemption. As a condition of claiming this exemption, nonresident purchasers and lessees must certify that they are not residents of Illinois. See ST-588, Nonresidency Exemption Certification for Sales and Leases of Motor Vehicles and Trailers, available on our website at **tax.illinois.gov.**
