As an example, the Metro East District rates are not applicable to every business in location 060-5000-2 (Madison) or 082-5000-9 (St. Clair). In this case, the high rate and low rate will be different and the override flag will be set to "Y". The high rate would only apply if the taxpayer were liable for Metro East District rates. Rate formats of v99999 would contain 06250 to represent a 6.250% tax (V06250)..

• The file will be generated semiannually every January and July and available on IDOR's website for downloading.

• The file will contain the current rate as well as the previous rate for each specific location.
